COMES NOW Texas Pacific Coal and Oil Company and requests the Commission to grant it an exception to Rule 5 of the Special Rules of the Jalmat Gas Pool for its State "A" a/c-2 Well #36, and for its grounds therefor states:

1. Applicant seeks a non-standard gas proration unit consisting of the  $S_2^1$  of Section 11, Township 22 South, Range 36 East, Lea County, N. M., and the allocation of an appropriate gas allowable to said unit.

2. The well to which Applicant seeks to have the allowable granted for its State "A" a/c-2 Well #36 is situated 660 ft. from the south and west lines of said Section 11. All of the said gas proration unit lies wholly within a single governmental section.
