3. Rigged-up reverse unit. Cleaned-out to 3303'.
4. Pulled bit, drill collars and 2" tubing.
5. Ran 100 Jts. 2" tubing. Set at 3104' D.F.
6. Sand-oil treated w/20,000 gal. oil, 60,000 lbs. sand and 500 lbs. Adomite.
7. Swabbed well off. Put on test.



