Ran 2958' of 7" 20# Seamless J-55 casing and set at 2967'. Cemented with 503 sacks 3% gel, 147 sacks Signalite and 200 sacks Neat. Circulated 200 sacks. Pipe and casing seat tested with 1000 psi for 30 minutes before and after the drilling out of the cement on December 5, 1953, and both held O.K.
