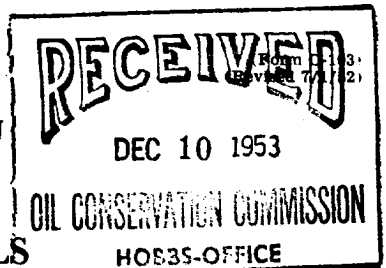

Well was spudded November 25, 1953.

Ran 323' of 9-5/8" 32# Seamless H-40 casing and set at 335'. Cemented with 300 sacks of Neat and circulated 40 sacks. Pipe and casing seat tested with 800 psi for 30 minutes before and after the drilling out of the cement on November 27, 1953, and both held OK.
