FULL DETAILS OF PROPOSED PLAN OF WORK  
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

In order to increase production, it is proposed to fracture treat as follows:

1. Pull 2-3/8" tubing. If warranted, clean out and plug back to 3743' with hydromite.
2. Run 2-7/8" tubing with formation packer set within the interval 3710-3690'. Treat formation below packer with 5000 gallons refined oil with 1 lb sand per gallon. Pull 2-7/8" tubing and packer.
3. Run 2-3/8" tubing, swab and test. If GOR is excessive pull 2-3/8" tubing and rerun with formation packer.
