Well plugged and abandoned as follows:

1. Set C. I. cement retainer in 4 1/2" casing at 3597'.
2. Squeezed open hole section 3642' - 3775' with 100 sacks regular cement and left 60' cement on top of retainer from 3537' - 3597'.
3. Perf. 4 1/2" casing at 350' with 4 bullets.
4. Circ. 125 sacks cement to surface on 4 1/2" x 8 5/8" bradenhead and left 350' cement in 4 1/2" casing from 0' - 350'.
5. Installed permanent well marker.
6. Mud laden fluid placed between all plugs.
