FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

TD 3750'; 8 5/8" casing at 342' cement with 125 sacks; 4 1/2" casing at 3682' cement with 150 sacks. Plan to plug and abandon well according to following procedure:

1. Set C.I. cement retainer at approximately 3600'.
2. Squeeze open hole section 3682' - 3750' with 100 sacks cement leaving approximately 50' cement on top of retainer.
3. Perf. 4 1/2" casing at 400' and circulate cement to surface on 4 1/2" x 8 5/8" braden-head leaving 400' cement in 4 1/2" casing from 0' - 400'.
4. Install permanent well marker.
5. Mud laden fluid between all plugs.
