1. The first group of variables is the set of variables that are used to describe the characteristics of the firm. These variables are: size, age, industry, and location. Size is measured by the number of employees, age by the year of establishment, industry by the two-digit SIC code, and location by the state of the firm's headquarters.

Figure 1. The effect of the concentration of the *Agaricus bisporus* spores on the growth of *Agaricus bisporus* on the substrate. The concentration of the spores was 10⁴ spores/ml (1), 10⁵ spores/ml (2), 10⁶ spores/ml (3), 10⁷ spores/ml (4), 10⁸ spores/ml (5), 10⁹ spores/ml (6), 10¹⁰ spores/ml (7), 10¹¹ spores/ml (8), 10¹² spores/ml (9), 10¹³ spores/ml (10), 10¹⁴ spores/ml (11), 10¹⁵ spores/ml (12).
