Plan to plug and abandon well as follows:

Set 5 1/2" C.I. bridge plug in 5 1/2" casing at approx. 3575', load hole with mud, and spot 150' cement plug from 3425' to 3575'. Perf. 5 1/2" casing at approx. 310' with 4 bullets, circulate cement to surface between 5 1/2" x 9 5/8" casing and leave 310' of cement in 5 1/2" casing. Install permanent well marker and clean up location.
