Set cast iron bridge plug in 7" casing at 3615'; spotted 100' cement plug from 3615' to 3515' with 22 sacks regular cement; tested casing with 1000# for 15 minutes, held OK. Perforated 7" casing at 1000'. Ran Guiberson Type B cast iron cement retainer on 2 7/8" tubing & set at 951'. Mixed 200 sacks cement & displaced down tubing. Good cement returns to surface out of 7" x 9 5/8" annulus. Spotted 50' cement plug on top of retainer. Spotted cement plug from 55' to surface in 7" casing. Cut off 7" casing & installed permanent well marker.
