State "H" No. 1 produces an average of 7 BOPD, 1 EWPD with a GOR of 14860. Top allowable is 40 BOPD with a limiting GOR of 10,000: 1.

It is proposed to plug back and sandfracture with 6000 gallons of sandfrac oil and 6000 pounds of sand. Recently, wall No. 2 on this lease was fractured upon completion with excellent results. It is anticipated that production can be increased to 27 barrels of oil per day with a GOR of approximately 15,000:1.
