Continental Oil Company respectfully requests administrative approval under the provisions of Rule 5 (b) of the Special Rules and Regulations for the Jalmat Gas Fool of Order No. R-520 for an enlargement to 320 acres of the existing approved 160-acre non-standard gas proration unit for its State E-17 No. 5 well located 1980' from the south line and 330' from the west line of Section 17, T-22-S, R-36-E, Lea County, New Mexico in the Jalmat gas pool.

- 5. Copies of this application have been furnished by registered mail to all offset operators and all operators within 1,500 feet of said well.

A plat is attached hereto showing to the best of our know-ledge and belief the proposed unit, the location of the well, and the offset ownership.
