Detailed account of work done, nature and quantity of materials used, and results obtained.

Plugging and abandonment of State E well No. 6 was done in the following manner: (1) Set 200 ft cement plug from 3200-3400', (2) Cut off 5-1/2" casing at 1565' and pulled same, (3) Set 20 sx cement plug at top of 5-1/2" casing, (4) Set 20 sx cement plug at 1460', (5) Set 10 sx cement plug at surface, and (6) filled intervals between cement plugs with 10 lb mud.

Plugging started 5-16-62 and completed 5-21-62.

The location was restored to its original condition. A 4 inch marker extending 4 feet above the ground was erected with the well name and location inscribed thereon.
