FULL DETAILS OF PROPOSED PLAN OF WORK

This well shut in incapable of commercial production. It is our intention to plug and abandon the subject well in the following manner: set a 200' cement plug from 3200-3400', shoot or cut 5 1/2" casing at free point and pull, set a 20 sx cement plug at top of 5 1/2" casing, set a 20 sx cement plug at 1460', set a 10 sx cement plug at surface and fill interval between plugs with 10 lb mud. Erect a 4" x 4' marker and restore location to original condition.
