The elevation of the derrick floor above sea level is 3607 ft.

### DETAILS OF WORK

(State names of and expected depths to objective sands; show sizes, weights, and lengths of proposed casings; indicate mudding jobs, cementing points, and all other important proposed work)

This well was drilled and completed November 16, 1940 in Seven Rivers producing horizon at 3816', plugged back to 3350' with cement and the hole loaded with mud. This well was plugged back in June, 1950. The 5 1/2" casing was shot off at 3246' and reclaimed approximately 3231' of same. The 8-5/8" casing was shot off at 226' and reclaimed approximately 211' of same. Ran 50 sax of cement at 1648' and got 140' of fill up. Ran 50 sax cement at 215' and got 128' of fill up. Ran 25 sax of cement at 60' and filled up into cellar. A 4' - 4" pipe, plugged on top, was left for a marker at the abandoned location. All surface equipment was reclaimed, cellar filled, location leveled and raked. Approval to plug this well was given June 23, 1950. Abandonment completed December 18, 1950.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
