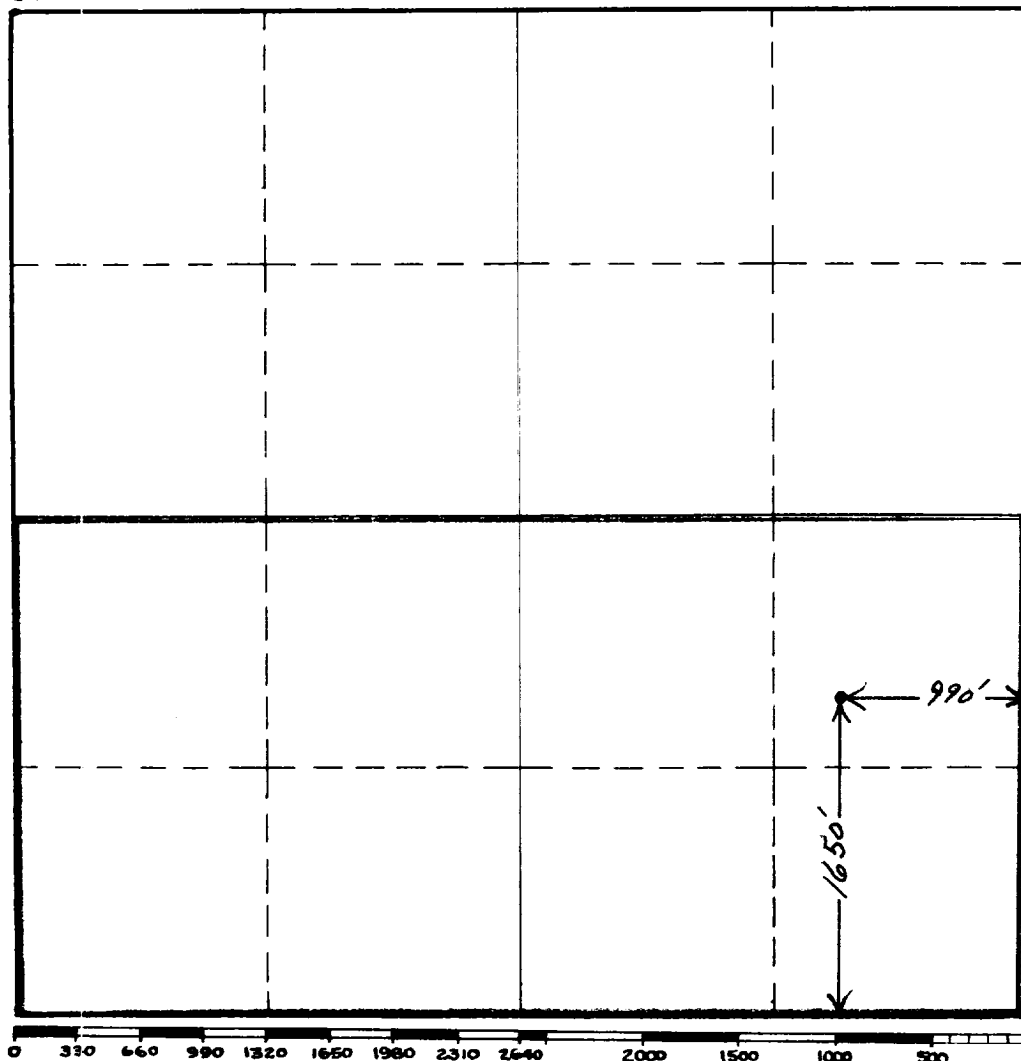

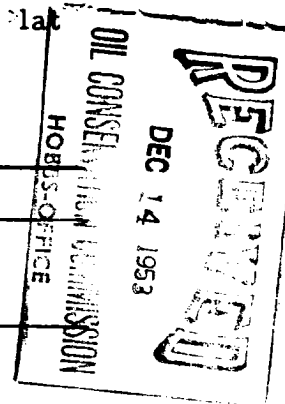
INSTRUCTIONS FOR COMPLETION:
