DETAILS OF WORK

It is our intention to drill a well with rotary tools at the above location to a depth of approximately 3350' unless commercial oil production is encountered at a lesser depth. All casing points will be cemented in accordance with approved methods of the U. S. Geological Survey and any other special requirements will be complied with.

The following casing pattern will be used: 3 5/8" casing will be set at approximately 1460' and cemented with 400 sacks cement, cement to return to surface. 5 1/2" casing to be set at approximately 3050' and cemented with 835 sacks cement or as determined by caliper survey.

Approval to produce this well upon completion is also requested.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
