DETAILS OF WORK

It is intended to drill this well with rotary tools at the above location to an approximate TD of 3825'. Casing will be cemented in accordance with U.S.G.S. standards and other special requirements will be complied with.

The following casing pattern is planned: 8 5/8" OD set at 350' with 350 sacks cement, cement to be circulated to surface, 5 1/2" OD casing set at 3825' with 1100 sacks cement. Depths and number of sacks cement are approximate. Exact amount of cement will be determined by caliper survey.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
