Sun Oil Company respectfully requests temporary exemption from the no flare rule, R520, for the H. J. Record Lease, South Eunice Pool, Lea County, New Mexico.

Well No. 1, South Eunice Pool
Well No. 2, Jalmat Oil Pool
Well No. 3, South Eunice Pool, GOR 1607 CPTB '66 MCF/D
Well No. 4, South Eunice Pool, GOR 975 CPTB 40 MCF/D

Wells No. 1 and No. 2 produce gas into the El Paso Natural Gas Company high pressure gas system. Exemption is requested for wells No. 3 and No. 4 which were recently completed as low pressure oil wells. The monthly gas production from wells No. 3 and No. 4 is approximately 3 MCF.

Sun Oil Company is now negotiating a gas sales agreement with the Union Carbon Company. The flaring of produced gas will be discontinued as soon as the sales arrangements can be completed.

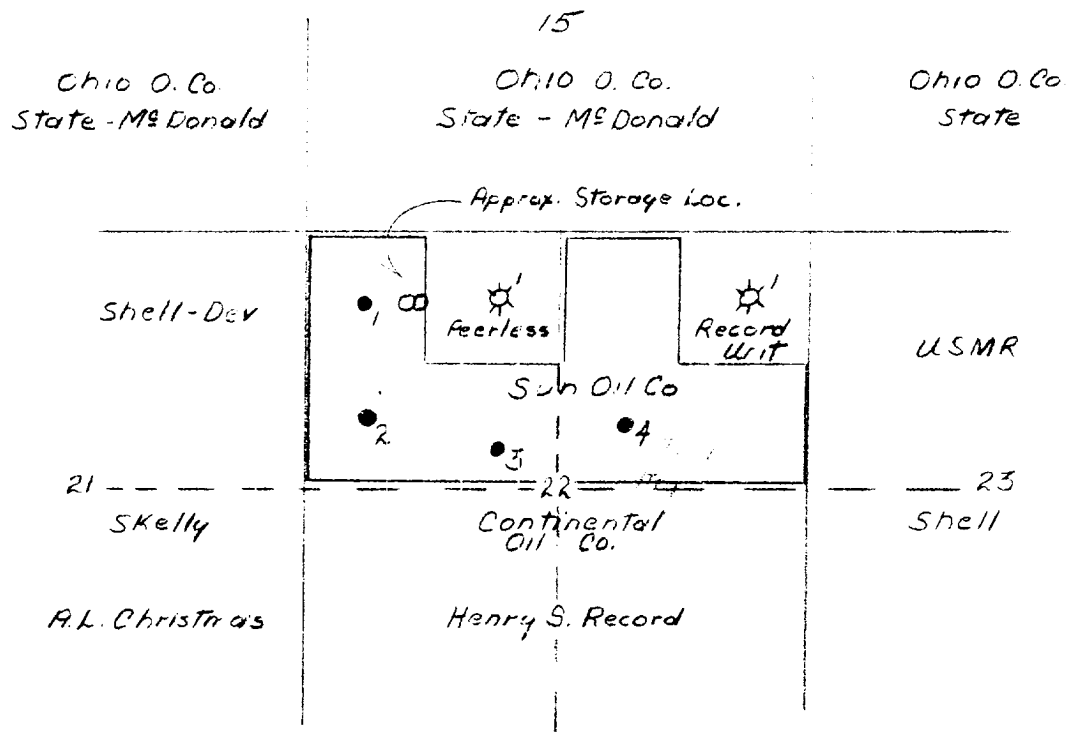
