DETAILS OF WORK

It is our intention to drill a well with rotary tools at the above location to a depth of approximately 3300', unless commercial gas production is encountered at a lesser depth. All casing points will be cemented in accordance with approved methods of the U. S. Geological Survey and any other special requirements will be complied with.

It is planned to use the following casing patterns: 10 3/4" casing to be set at approximately 250' and cemented with 200 sacks cement; 5 1/2" casing to be set at approximately 3120', or on top of Yates formation, and cemented with 990 sacks cement.

SE 1/4 of Section 23 assigned for gas well. (160 acres).

Approval to produce this well upon completion is also requested.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
