Spudded 11" hole 3-16-62, drilled to 432'. Ran 10 joints 8 5/8", 24#, J-55 casing to 422'. Cemented by B. J. Service 2 plug method with 225 sacks Trinity regular with 2% calcium chloride. Cement circulated. W.O.C. 12 hours. Tested casing with 1000# for 30 minutes, held OK.

- 263 cubic feet of cement slurry.
- Trinity regular cement, with 2% calcium chloride.
