Macdonald Oil Corporation herewith submits application for administrative approval of a dual completion (conventional) for the Gulf Meter No. 1 located 1650' from the east line and 1980' from the south line of Section 30, Range 21 South, Township 37 East, Lea County, New Mexico. It is proposed to complete this well in the Paddock and Drinkard Oil Pools and to produce each zone through parallel strings of 2-1/8" tubing installed in 7" casing.

Attached are Application for Dual Completion, lease plat, and diagrammatic sketch of the proposed dual completion.

Administrative approval is being requested since there are a number of completions of this type in the field, one being Order R-2371 granted to Gulf Oil Corporation on the Graham State (NCT-1) No. 2, Unit 1, Section 19, 21S, 37E.
