FULL DETAILS OF PROPOSED PLAN OF WORK  
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

This hole has been drilled to depth of 8160' and is bottomed in black shaley lime. We propose to abandon hole at present depth. 13-3/8" casing was cemented back to surface from depth of 287'. 9-5/8" casing was set at depth of 3736'; in brown dolomite below the salt section; and was cemented back to surface.

To best of our knowledge we have encountered no commercial shows of oil/ and or gas. We therefore propose to leave hole filled with mud of weight 9.0# and viscosity 36 and set a cement plug in top of casing with regulation marker set therein. When rig is removed from location we will backfill all pits; clean up around location and leave location site as nearly in original condition as is reasonably possible.
