Detailed account of work done, nature and quantity of materials used, and results obtained.

Drilled 7 7/8" hole to 4,000' TD. Ran 111 joints (4001.45') 5 1/2" J-55 14# & 15.5# ST&C casing. (773.97' 15.5# on top). Cemented casing with seat at 3,996' with 225 sacks cement, 225 sacks posmix and 4# jel making a total cement mixture of 800 cubic feet. This volume is calculated from caliper surveys to fill annular space to a height of 1550' or 227' above the top of the Rustler section found at 1770' in this well. Plugs were pumped down and seated at 10:00 PM 8/16/64. WOC 18 hours. Tested cement and casing with 1500 psi for 30 minutes with no loss of pressure.

Plugs will not be drilled to leave new TD at 3,978.25' DF measurement (DF 12.3' above GL).


Prepair to complete well 44 hours after cementing.
