Spudded 12 1/4" hole 8:00 PM, August 7, 1964. Drilled to 325' in red beds. Ran 320' 8 5/8" 24# J-55 casing and cemented casing by pump and plug method with 175 sacks Halliburton posmix cement with 2% calcium chloride. Cement circulated. Plug on bottom 5:00 AM August 8, 1964. WOC 16 hours then test cement and casing with 1,000 psi for 30 minutes and found no loss of pressure. Drilled plug with 7 7/8" bit and prepare to drill to TD.
