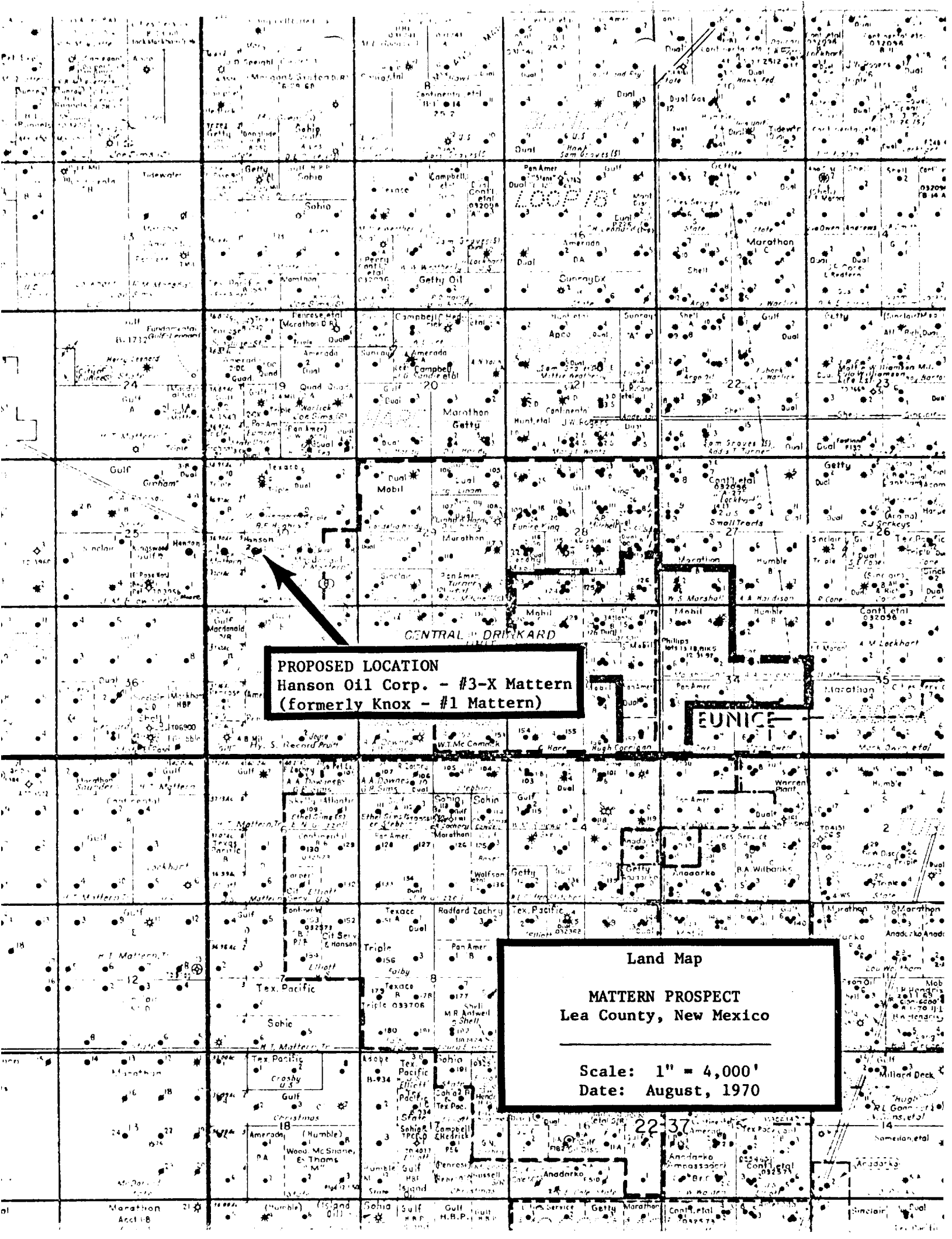

Lea County, New Mexico

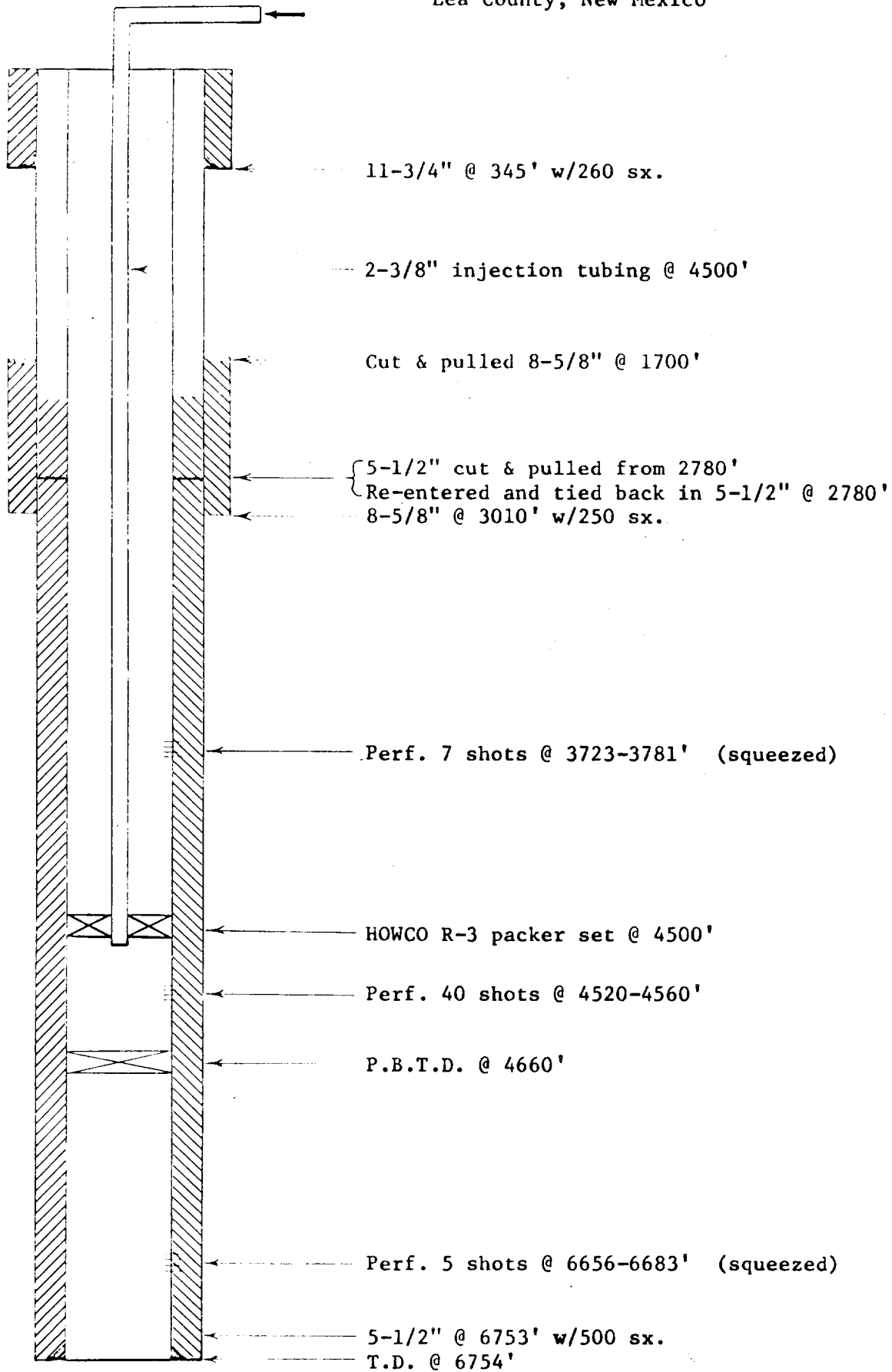
