After WOC 18 hours, tested casing with 1000 PSI for 30 minutes. Test OK. Reduced hole to 7-7/8" at 1218' and resumed drilling operations.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
