Administrative Order No. MC-1523 granted TEXACO Inc. authority to tubingless dually complete E.H.B. Phillips Well No. 3 located in Unit G of Section 10, Township 20 South, Range 37 East. NMPM, Lea County, New Mexico, in such a manner as to produce oil from the Blinebry formation adjacent to the Weir-Blinebry Pool and the Tubb formation adjacent to the Monument-Tubb Pool.

This is to advise that the well mentioned in Order No. MC-1523 has been re-designated as E.H.B. Phillips "B" Well No. 2 and the well completed in the Tubb and Drinkard formations rather than in the Tubb and Blinebry formations. After drilling the well to total depth and conducting logging survey, the Drinkard formation appeared prospective for production and was completed as an oil producer. The Tubb and Drinkard formations have previously been authorized for dual completion by the New Mexico Oil Conservation in TEXACO Inc. M B. Weir "B" Well No. 7 by Commission Order R-2392.

In view of the aforementioned, TEXACO Inc. respectfully requests administrative approval to dually complete E.H.B. Phillips "B" Well No. 2 in such a manner so as to produce oil from the Tubb formation adjacent to the Monument-Tubb Pool and Drinkard formation adjacent to the Skaggs Drinkard Pool through parallel strings of

In view of the above-mentioned facts and the fact that the Board has no authority to approve or disapprove the actions of the Board of Directors, it is recommended that the Board of Directors be authorized to take such action as may be deemed appropriate.
