It is proposed to drill and test the Carron Unit well No. 29 using the following program:

- (1) Drill to 1400' & set 8 1/2" surface casing.
- (2) Drill to 4225' & set 100' core in Pecos (Pecos-Queen) formation.
- (3) Drill to 4025' & set 100' core in Grayson-Lee Andres (Munsat) formation.
- (4) Drill to 4250' & run open hole logs as specified.
- (5) If logs so indicate, run 3 1/2" production casing & bring cement to base of hole.
- (6) Run depth control log, perforate, stimulate & test shallow Permian formations according to log and core analysis.

Your approval is requested for the above work.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 1: If the proposal is to redrill to the same reservoir at a different subsurface location or to a new reservoir, use this form with appropriate notations. Consult applicable State or Federal regulations concerning subsequent work proposals or reports on the well.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

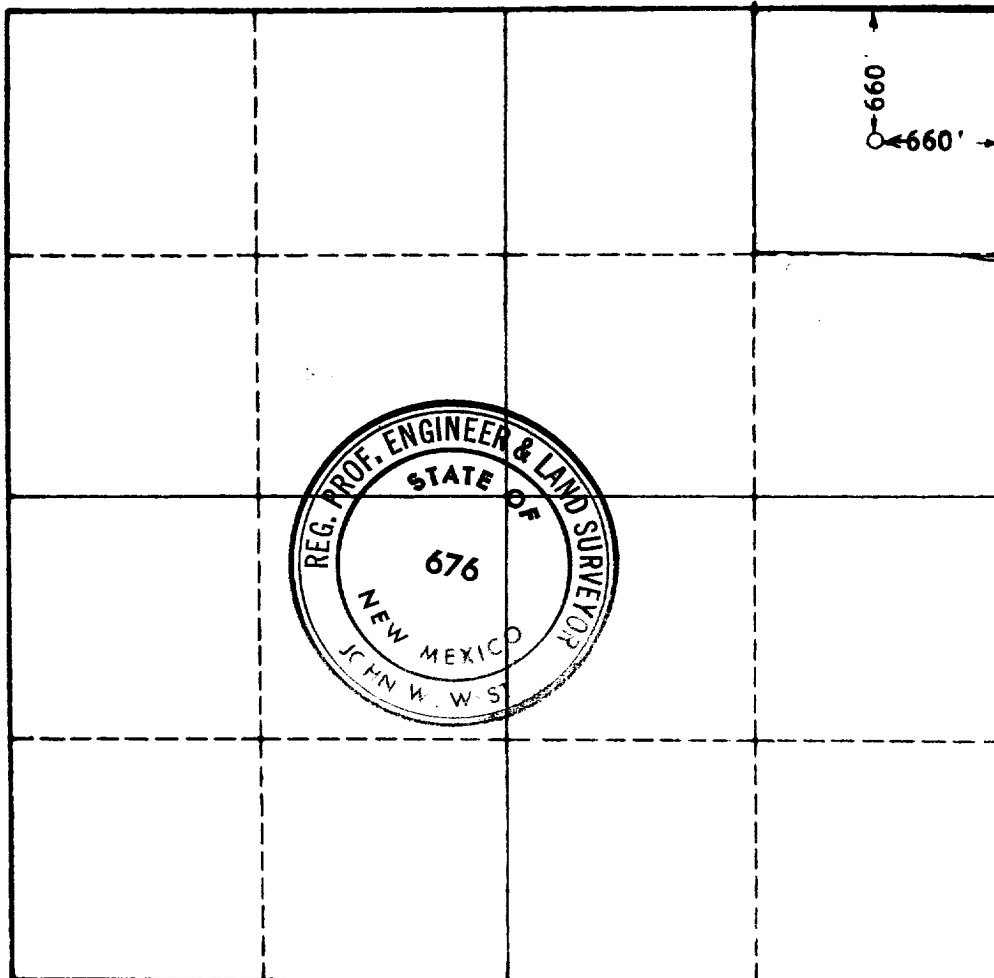
