Gentlemen:

Attached is an application by TEXACO Inc. for dual tubingless completion for the C. H. Weir "A" Well No. 11, located 1980 feet from the north line and 2310 feet from the east line, Unit G, Section 12, T-20-S, R-37-E, Lea County, New Mexico. TEXACO Inc. intends to complete this well in the Skaggs Drinkard Pool and an undesignated Tubb oil pool through parallel strings of 2-7/8 inch casing cemented in a common well bore. It is anticipated that all zones will be oil completions and will flow initially. Approval has been granted previously by the New Mexico Oil Conservation Commission for these zones in TEXACO Inc. M. B. Weir "B" Well No. 7.

Also attached is a copy of the plat showing the area immediately surrounding TEXACO Inc. C. H. Weir "A" Lease and a diagrammatic sketch of the proposed dual tubingless completion. It is respectfully requested that TEXACO Inc. be granted administrative approval for this application as provided for under Rule 112-A.
