Drilled to 4454' (5-27-64). Lost circulation & stuck drill pipe @ 4439'. Shot off drill collars at 3645. Fished & recovered 29 drill collars, leaving one square drill collar, two reamers, & bit (32') in hole. Drilled over fish, but could not recover.

It is proposed to set a cement plug & sidetrack fish.

Recommended procedure:

- (1) Set cement plug 4050-4415 using 150 ex Class A cement, 2400# sand w/2% UA-5.
- (2) Drill out to 4150'.
- (3) Set whipstock & sidetrack fish.
- (4) Resume drilling operations & complete as previously reported.

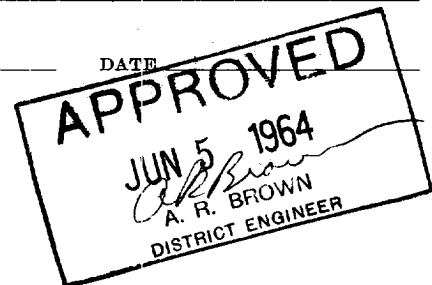

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
