2. Killed well. Set RBP in Drinkard @ 6714' and spot sand on top of plug.
3. Testeu perfs 5700-6036'.
4. Perforate 2-7/8" Drinkard csg w/2 JSPF from 6026-6036'.
5. Acidize 2-7/8" csg perfs 6026-6036' w/250 gals. 15% HCl HE acid. Flushed w/40 Bbls. water.
6. Pull RBP from Drinkard string. Install producing equipment.
7. Tested and place on production. Completed downhole commingling.
