1. Spotted 130 sacks cement containing 26 sacks of sand from 10,094' to 9,820'. WOC 24 hours. Deviation 7-1/2° @ 10,083'.
2. Checked top of cement at 9,820' and dressed of to 9,867'. Ran survey and found deviation of 3-3/4° south 87° east at 9,867'.
3. Ran whipstock orientated north 87° west. Drilled 6-5/8" hole off whipstock to 9,883'. Reamed hole to 8-3/4" to 9,883'. Ran survey and found deviation of 1-3/4° north 56° east at 9,883'.
4. Now drilling ahead.
