The original frac. was unsatisfactory because of equipment failure. The well was producing 13 BO + 1 BW per. day. All of the original frac. oil was recovered. Oct. 21, 1966 the well was re-frac with 15,000 gal. RO, 15,000 lbs. 20-40 sand, 400 lbs adomite using 6 - 15/16" balls. The well produced 61 BO + 2 BW per day after fracing. The above treatment was through the original perforations, 3806, 12,17,27,35,44,48' (7 - 1/8" holes)
