It is planned to drill with water to 300', set 13-3/8" casing and circulate cement to surface, drill out with brine water to 2830', set and cement 8-5/8" casing, then drill with fresh water low solids mud to TD at approximately 7300', run Gamma Ray-Sonic logs, set and cement 5-1/2" casing at TD, complete by perforating and acidizing the lbo interval.
