1. Spot 35' cement on top of C.I.B.P. @ 3500'.
2. Circulate hole with mud.
3. Spot 25 sxs cement 2910-3150'.
4. Spot 25 sxs cement 1060-1300'.
5. Perforate 5 1/2" casing at 470'.
6. Circulate 130 sxs cement to fill 5 1/2" and 8 5/8" x 5 1/2" annulus to 470'.
7. Install dryhole marker. Clean location.
