Dear Mr. LeMay:

Chevron U.S.A. is planning to recomplete the H. T. Mattern NCT-F # 4 in the Eumont (7RVRS) Gas Pool. The well currently is completed in the Blinbry and the Drinkard and commingled downhole. The location of the proposed recompletion is 660' FNL and 1650' FEL in Section 1, T22S, R36E, Lea County, New Mexico.


Chevron proposes the creation of a new Eumont Gas Proration Unit for well # 4. The proposed new Gas Proration Unit will be the N/2 of NE/4 of Section 1, T22S, R36E and will be 80 acres in size. Well # 4 will be the only Eumont well in this proration unit and is at a standard gas well location.
