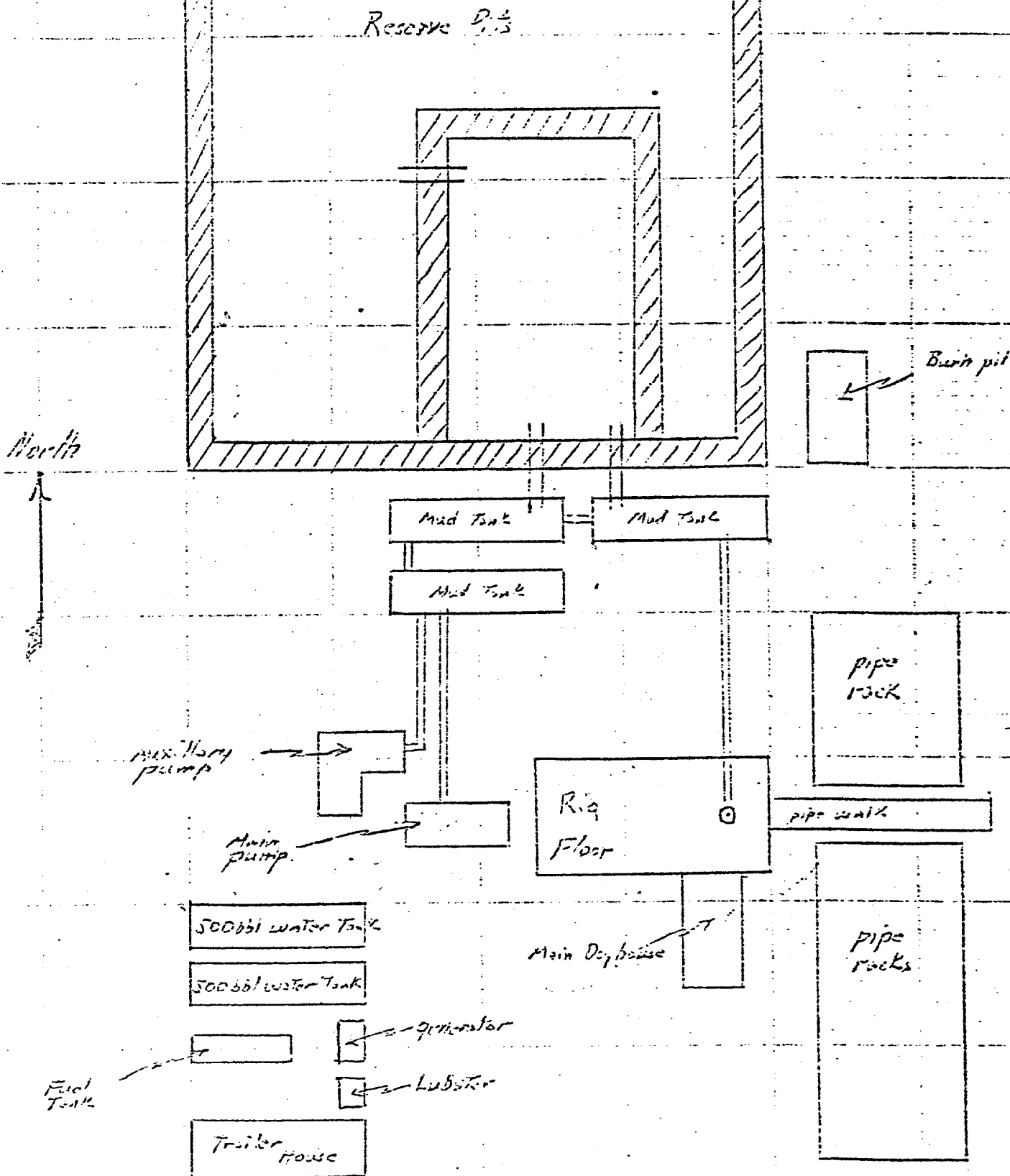
11. Plans for restoration of the surface

The terrain in this area is generally flat with very little vegetation. No streams or other major water sheds are located in this area.

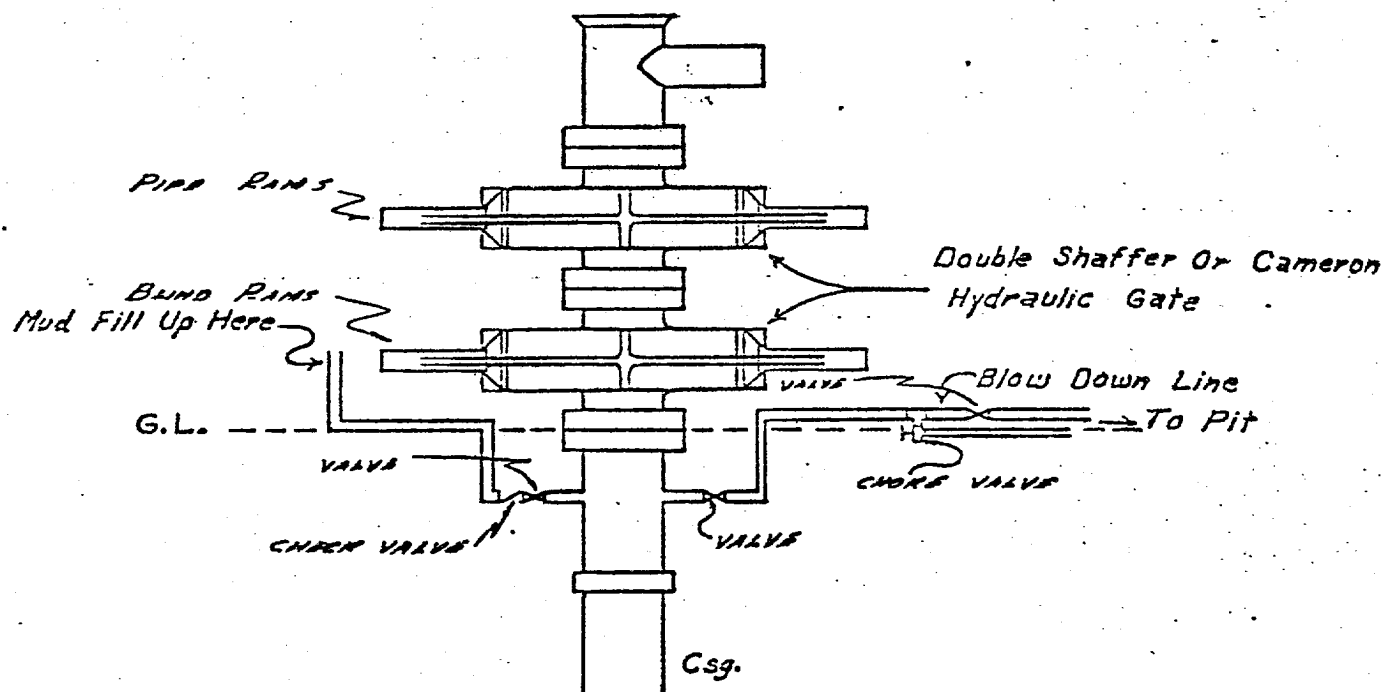
