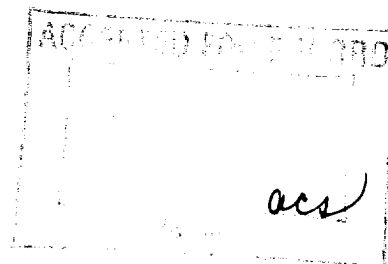

3-4-00: RIH w/RBP & set @ 6600' over Drinkard perms @ 6642-6841'. Tested RBP to 500#, tested OK, SION.
3-6-00: Spot 4 sx of 20/40 sand on top of RBP. Rigged up Atlas wireline, RIH & perforated w/2SPF from 6430-6498'. SI.
3-9-00: RIH w/2 7/8" tubing, set packer @ 6361', acidized well with 75 bbl frac w/ball sealers. Well started to flow, SION.
3-14-00: Fraced well w/13,460# 100 mesh and 68,340 16/30 TLC & 40,400# 16/30 SLC w/1226 bbls to recover. Flowing to frac tank.
3-18-00: RIH with production string - 2 7/8" with production packer @ 6365'. SION.
Well put on production.
