After spudding, drilling & setting 9-5/8" OD csg. (Re: Sundry report dated 9/11/75), drilled a 8-3/4" hole out under 9-5/8" csg. to 3600' 9/14/75, run, set and cemented 7" OD 23# new casing at 3599' with 500 sx. lite wate and 200 sx. Class "C" cement by Dowell and WOC at 9 PM 9/14/75. Wait on cement for 24 hrs., run temp. survey, found top of cmt. outside 7" csg. at 1810', TTH W/bit and tested casing and drill pipe runs W/1000#, held O.K. and started drilling out under 7" casing @ 3599' at 10 AM 9/16/75.

Plan to drill a 6 1/4" hole to PTD of 5250', log well and if productive, set 5" liner at TD back to +/- 3550' and single complete in Paddock zone.
