On July 12, 1978, this office approved Form C-104 granting a 3000 MCF testing allowable for your Boren & Greer Gas Com Well No. 2 located in Unit C of Section 21, T-22-S, R-36-E. This form stated that a potential would be taken on the well upon connection to a sales line, which was done on July 11. No further reports have been submitted, however.

In order to complete our file and in order that an allowable can be assigned, please submit Form C-103 covering the running and testing of each string of casing in the well, a completed Form C-104, Form C-105, and two copies of a notarized tabulated list of the deviation surveys.

Further, on March 15, 1978, Form C-101 outlining your intent to plug your B. Lee State Well No. 5 located in Unit M of Section 7, T-18-S, R-35-E, back to the Grayburg was approved, but no further reports have been submitted for this well. Therefore, please submit Form C-103 covering any work that has been done and indicating the present status of the well. If the work has not been done, please indicate on Form C-103 your intent in this regard.
