Existing Blinebry perfs 5974' - 6027'. Released packer, POH w/tubing. Perforated Blinebry 5912', 5913', 5914', 5915', 5916'. Run packer and retrievable bridge plug. Set BP @ 5950'. Treated perfs w/2000 gals 15% acid @ 4.5 BPM and 3300 psi. ISIP 4800, 10 minsip vacuum. Swabbed 20 Bbls and started flowing. Flowed 196 Bbls fluid cutting 95% oil in 15½ hours. Retrieved bridge plug. Ran production packer and set at 5856'. Swabbed and left flowing. Flow tested 210.7 Bbls oil, 6 Bbls water, and 285.1 MCF gas per day on 24/64" choke with 150 psi FTP.
