AMENDED ADMINISTRATIVE ORDER DHC-337

Dear Ms. Maddox:

Reference is made to your recent application for an amendment to Division Order No. DHC-337 dated April 27, 1981, which authorized Conoco Inc. to downhole commingle Blinebry Oil & Gas and DK-Abo Pool production within the subject well. It is our understanding that the Abo zone will be abandoned and the well commingled in the Blinebry Oil & Gas and East Warren-Tubb Pools.

It appearing that the subject well qualifies for approval for such amendment pursuant to the provisions of Rule 303.C., and that reservoir damage or waste will not result from such downhole commingling, and correlative rights will not be violated thereby, you are hereby authorized to commingle the production as described above and any Division Order which authorized the dual completion and required separation of the zones is hereby placed in abeyance.

In accordance with the provisions of Rule 303.C., the daily allowable producing rates from the subject well are hereby established as follows:

Oil 107 B/D

Gas 428 MCF/D

Water 214 B/D

Production from the subject well shall be allocated as follows:

Gas and oil production from the Blinebry Oil & Gas Pool shall be determined utilizing the production forecast submitted by the applicant as an attachment to the downhole commingling application. Gas and oil production from the East Warren-Tubb Pool shall be determined by subtracting Blinebry Oil & Gas Pool production from the well's total monthly gas and oil production.


The allocation method established herein may be altered at some time subsequent to initiating downhole commingling operations upon request by the operator and for good cause shown.

REMARKS: The operator shall notify the Hobbs District Office of the Division upon implementation of the commingling process.

Pursuant to Rule 303.H., the commingling authority granted herein may be rescinded by the Division Director if conservation is not being best served by such commingling.
