2. Perforate Blinebry 5770'-5882' (21 holes), 5899'-5920' (6 holes), 6062-6127' (15 holes), 6157'-6237' (9 holes), 6278'-6380' (23 holes).
3. Isolate each zone with RBP & packer & acidize same (total 14,000 gals 15% NEFE acid.)
4. Swab back load, return well to production.
