Pulled rods & tubing, ran packer to 5390'. Treated perms with 3000 gallons lease crude containing 15 gals Musol-A and 15 gals Hyflo III. Treated at 2.9 BPM and 5100 psi. Max rate 3.7 BPM @ 5500 psi. Balled off. Flowed & swabbed 71 bbls fluid and released packer. POH. Run tubing, rods and pump back. Pumping 32 bbls oil, 2 bbls water & 31 MCF gas per day.
