May 15, 1985 to May 24, 1985 - Set blanking plug in bottom half of on-off tool above Model D pkr. set at 6765'. Drinkard zone temporarily abandoned. Pulled Tubb zone rods, pump & tbg., pulled Drinkard zone tbg. Laid down one string of tbg. Ran pkr. & tbg. & acidized Tubb zone thru 7" csg. perf. fr. 6493' to 6660' w/3000 gal. 15% acid. Swabbed load. Re-ran tbg., pump & rods and resumed pumping as single zone Tubb pumping oil well.
