Drilled well to a total depth of 3830'. Ran 92 joints (3831.91') of 7" OD, 26 lb/ft, ST&C casing and landed at 3830'. Cemented with 500 sx of API Class C cement containing 3% Econolite, 5 lb/sx Gilsonite and 1/4 lb/sx Floseal followed by 300 sx of a 50-50 blend of Pozmix A containing 18% Salt, 5 lb/sx Gilsonite and 1/2 lb/sx Floseal. Plug down at 5:30 a.m. 12-07-85. Circulated 200 sx excess cement to pits. Pressure tested casing to 1500 psi and pressure held okay. Released pressure and float held okay.
