Propose to set CIBP @ 3372'. Circ hole w/pkr fluid & return well to TA status.

Propose to test csg to 500# for 30 min & return well to TA status. Remedial work and test will be performed within 30 days of approval. Received "Notice of Written Order" - request a 30 day extension from date of approval of Sundry notice.
