THE UPPER MORROW WAS PERFORATED FROM 12,840' - 12,844'; 12,890' - 12,900'; 12,990' - 12,998'; 13,006' - 13,018'. THE UPPER MORROW WAS TESTED AND FOUND TO BE NON-PRODUCTIVE. WE WILL LOAD THE HOLE WITH 10 PPG BRINE, SET A CIBP AT 12,830', TEST CIBP AND DUMP 35' CEMENT ON TOP OF CIBP PER VERBAL INSTRUCTIONS FROM SHANNON SHAW IN THE CARLSBAD, NM BLM OFFICE. WE WILL ATTEMPT A COMPLETION IN THE ATOKA WITH PERFORATIONS FROM 12,530' - 12,566'; 12,584' - 12,618' (70' TOTAL).

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 5: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State office.
