BTA Oil Producers would like to apply for an exception to Rule 402 - Shut-In Pressure Test on the above referenced well.

The well is currently producing 2755 MCFD, 40 BOPD, and 220 BWPD with FTP 380 psi. Due to the large volume of water the well is producing, it is felt that the well would not recover naturally from a shut-in period. Any shut-in period on this well could result in an expenditure upon attempting to return the well to production. Also a possible loss of reserves if the production was not recovered.
